RECOMMENDATION

Staff Recommends That The City Council Adopt A Resolution Acknowledging The Urgency And Expediting Actions To Remedy Illegal Dumping Through An Illegal Dumping Expenditures Action (IDEA) Plan:

- 1) Authorizing The City Administrator To A) Implement The IDEA Plan By Negotiating And Entering Into Contracts, Grant Agreements, And Expenditures As Set Forth In Table 1 In A Total Amount Not To Exceed \$1,100,000; And B) Pursue Partnerships With County, Regional And / Or State Agencies To Enhance These Efforts;**
- 2) Waiving, To The Extent Necessary, The City's Advertising, Competitive Bidding, And Local /Small Local Business Enterprise Program Participation And Multi-Step Technology Acquisition Requirements For The Contracts; And Waiving The Local / Small Local Business Enterprise Program Requirement For The Big Truck Rental (Lightning Loader) Contract;**
- 3) Appropriating And Allocating An Amount Not To Exceed \$1,100,000 From Budgeted Funds In Fund 1720, Comprehensive Cleanup Fund, For These Purposes;**
- 4) Accepting And Appropriating Additional Funds From Public And Private Sources And Authorizing The City Administrator To Actively Seek And Apply For Such Funds And To Amend Existing Contracts And / Or Enter Into New Contracts Consistent With The Purpose Of This Resolution And In Furtherance Of The Plan In A Total Amount Not To Exceed The Value Of Such Additionally Appropriated Funds; And**
- 5) Directing The City Administrator To Return To Council Within One Year Of The Adoption Of This Resolution To Provide An Informational Report On Actions Taken, Funds Received And Expended, And Contracts**

EXECUTIVE SUMMARY

Illegal dumping is an urgent issue which harms our communities in many ways including damaging public health, impeding pedestrian access, undermining economic development and business success, causing environmental harm, and negatively impacting public safety. As one of several actions to address this, Oakland City Council appropriated \$1,100,000 in its 2025 – 2027 adopted biennial budget, for the purposes of investing in innovative solutions to address illegal dumping.

The Illegal Dumping Expenditure Action Plan (Plan) proposes utilizing this funding to initiate and supplement a series of new and existing education, eradication, and enforcement efforts to address this crisis. Proposed actions include:

- Contracting with an aerial camera company to locate piles of dumping for expedited remediation.
- Purchasing software and technology devices that will facilitate the process to issue and collect illegal dumping citations.
- Adding new and replacement equipment for crews that pick up illegal dumping.
- Authorizing additional staff time to pick up debris in the right of way and/or host bulky block parties for residents to bring large debris items for disposal.
- Adding additional capacity to the city's existing contract with the vendor for its illegal dumping surveillance cameras for more technical assistance and purchasing solar powered cameras.
- Providing funds to community partner Keep Oakland Beautiful for their assistance with getting information to residents on bulky waste disposal services.
- Contracting with a consultant to do direct outreach to multifamily properties to educate and support their utilization of existing bulky waste disposal services.

The Plan also authorizes the City Administrator to accept funding from public and private sources for the purposes of implementing technological solutions, engaging additional labor support, and supporting programs that directly address the illegal dumping crisis which disproportionately impacts the city's frontline communities of color. Many residents in these neighborhoods experience the negative effects of piles of debris in their community on a daily basis. It is a priority of the city to address this issue so that all residents can live in dignity and safety.

BACKGROUND / LEGISLATIVE HISTORY

Oakland spends millions of dollars annually on personnel, equipment, and debris disposal fees to address illegal dumping. The Public Works Department (OPW) alone has 50 budgeted staff assigned to its Keep Oakland Clean and Beautiful division, Illegal Dumping Unit (IDU). Staff from the IDU often spend up to seven days a week on assignments to remediate dumping in the public right of way and there are additional staff in the OPW Parks and Trees Services division who address illegal dumping in parks. In OPW's Environmental Service Division, the Environmental Enforcement Unit (EEU) is comprised of 8 staff dedicated to catching illegal

dumpers, issuing citations, and engaging in other enforcement activities, such as ensuring businesses are signed up for mandatory trash service, that help reduce illegal dumping.

While the current investment in resources to address illegal dumping is significant, there is still more that needs to be done to combat the problem. As such, the city is redoubling its efforts at a three-pronged approach known as the “Three Es: Eradication, Education, and Enforcement.” Efforts to eradicate debris by picking it up and disposing of it must be supported by new technological innovations and additional equipment and personnel resources. The city needs to invest in stronger and streamlined enforcement mechanisms including higher fines for dumpers, improved processes to ensure citations are paid, and additional technology tools and innovations to ensure that dumpers are caught. Educational programs and campaigns must be bolstered by new investment and convey a broad, citywide sentiment around social norms for the management of waste and include targeted outreach to residents who may need additional support and resources to access and utilize existing, appropriate waste disposal options.

The Oakland City Council recently adopted several measures that underscore the city’s commitment to this issue including:

- Increasing fines for those who are caught dumping, holding vehicle owners responsible if their vehicle is used in a dumping case, and making it illegal to transport waste across the city without a license plate.
- Investing in new aerial camera technology to quickly and equitably spot illegal dumping piles and deploy crews for cleanup, approved per Resolution No. 91112 C.M.S.
- Supporting proposed state legislation that would allow the California Department of Motor Vehicles to collect unpaid illegal dumping fines and prohibit vehicle registration renewal until such fines are paid, approved per Resolution No. 91110 C.M.S.

These actions along with other operational and policy initiatives provide a basis of support for the actions recommended in the Plan.

ANALYSIS AND POLICY ALTERNATIVES

To bolster and enhance illegal dumping prevention efforts, the Plan proposes a series of new and/or supplemented actions, each of which falls into one of the “three Es” categories of Eradication, Eradication, and Enforcement as described below.

Eradication

Quickly removing piles of debris is the first line of defense in the battle against illegal dumping. Illegal dumping left on the streets often attracts additional dumpers, with some becoming popular recurring dump locations known as “hot spots.” To combat this, OPW crews endeavor to clean up materials as quickly as possible but the amount of personnel, available working hours, and functional equipment limit how much can be collected daily. The following actions are recommended to bolster existing resources.

- **Aerial camera system and data analysis to track dumped trash**, locations, volumes, and identify cleared locations, photos, clear complaints. On April 14, 2026 City Council authorized the City Administrator to enter into a contract with Aerbits, Inc. (approval per Resolution No. 91112 C.M.S.) to pilot test a new system to identify locations of illegal dumping with aerial imagery. This system, which has also been reviewed and approved by

the Privacy Advisory Commission through action taken on March 5, 2026, aims to more equitably and comprehensively locate debris piles along contiguous routes to more quickly notify KOCB crews of its location, create faster and more efficient clean up routes, and to record pre and post images of debris clearing for better tracking and closing of duplicate or outdated service requests. While already authorized through Council action, the item is noted here as the funding would come from the same budgeted allocation of funds as the other actions.

- **Rent up to two “Lightning Loader” trucks and purchase additional equipment (e.g. pickup truck, trailer).** Grapple loaders (also known as lightning loaders) are large trucks equipped with a grapple arm that can grab and load large quantities of debris. These are essential pieces of equipment that reduce manual labor and increase the rate at which crews can perform cleanup. OPW currently has two such vehicles in its fleet, however, they regularly need repair or maintenance, and one or more is often deployed to encampment intervention operations. Ensuring the KOCB crews have a working lightning loader to deploy for cleaning is critical to operations. Additionally, KOCB has identified the need for an additional pickup truck and trailers to transport smaller equipment to cleanup locations.
- **Staffing, including overtime, to expand cleaning surges to clear illegal dumping comprehensively and proactively from hard-hit areas, zone-based deployment for remediation, and bulky block parties.** In recent budget cycles there has been less funding available for additional staff time to supplement cleaning that occurs on the standard workday. Through authorizing funding of additional proactive cleaning work and/or hosting bulky block parties for residents to dispose of unwanted large items, crews will be able to target hard hit communities for additional eradication support and reduce the frequency of repeat dumping. Such staffing surges have been shown to make a visual impact in neighborhoods and reduce the backlog of service requests that typically slow the city's response time.

Education

One of the identified best practices to help remedy illegal dumping is to ensure all community members are aware of and have access to proper waste disposal options. In addition to curbside waste pickup, the city offers bulky item curbside pickup and drop-off appointments through its mixed materials and organics franchise agreement with Waste Management. These services provide all residents (property owners and renters) with free disposal options for items such as furniture and mattresses, appliances, tires, and other large household debris items that are often found in illegal dumping piles. The city tracks usage of these appointments and has demonstrated that they are significantly underutilized by all residents, but more so by renters. Increasing awareness of and access to these services is an educational priority of the City.

Citywide education and behavior change campaigns focused on litter reduction and preventing illegal dumping are another critical piece of the strategy. Such campaigns demonstrate citywide priorities, communicate behavioral norms, help residents learn about and access services, and foster a sense of common identity (such as being a community that prioritizes a clean environment), and civic pride. Litter reduction and dumping prevention campaigns in other communities have demonstrated significant behavior change outcomes around reducing littering and increasing proper waste disposal. Such campaigns can shift poor habits and practices into intentional, responsible waste management, and empower youth to be change leaders in their communities, and help ensure that underserved communities are given information about, and access to, free bulky waste removal services.

This expenditure plan would expand the city's educational efforts around illegal dumping with the following actions:

- **Partner with Keep Oakland Beautiful (KOB) for community outreach and education.** Community partners are critical for effective outreach and through this partnership, KOB, a local non-profit, would assist the city in promoting bulky waste services through a direct mail campaign and messaging at their events, as well as promoting other messages around preventing and reporting illegal dumping.
- **Display ads, transit ads, posters, billboards.** The city has already developed some promotional materials around bulky waste services that are currently being displayed at no cost on electronic kiosks and digital billboards around the city. This expenditure would expand the promotion of those message and content on preventing and reporting illegal dumping in transit ads and other media placement.
- **Direct outreach to property managers and community organizations, and distribution of materials to post and share.** To increase the use of the available no-cost, bulky waste disposal services this expenditure would provide direct outreach to residents, owners, and property managers of multi-family properties who are the customers who utilize these services the least. Outreach would include information on and assistance facilitating the use of existing bulky disposal services, education on proper waste disposal including recycling and composting, and information on how to report and prevent illegal dumping.

Enforcement

To enforce against those who dump litter and debris in the streets and public spaces requires first identifying those responsible for the dumping and then issuing and collecting fines and penalties. Multiple techniques are used to identify dumpers including locating identifying materials in piles of debris (such as a piece of mail), witness statements, photos and video submitted by witnesses and community members, and catching illegal dumpers on cameras such as those used by the OPW EEU. The camera technology used by OPW for such efforts has already been approved and authorized by the Privacy Advisory Commission and the Oakland City Council.

The Plan would strengthen enforcement in multiple ways including adding additional camera units and improving the process by which by illegal dumping citations are issued, tracked, and fines are collected through the following recommended actions:

- **Additional cameras, including solar-powered cameras, and related supports for the OPW illegal dumping camera system.** This action will support deployment and relocation of additional surveillance cameras - currently OPW has only 35 cameras and hundreds of illegal dumping hot spots – including the introduction of solar powered cameras that do not rely on direct access to an electrical connection to function. Identifying live electrical poles can be a limitation to installing a surveillance camera where either such a pole does not exist or when OPW needs to wait for long periods of time for the electrical service to be restored. Solar-powered cameras may prove to be more mobile and relocatable. Additionally, this action would include expanding the city's existing contract with the camera system vendor, Security Lines U.S. for additional technical support reviewing footage and troubleshooting camera technical issues.
- **Technology, including hand-held devices and associated software, system updates, and training for Environmental Enforcement Officers.** One of the primary enforcement challenges has been difficulties collecting monetary penalties associated with illegal

dumping citations. To increase their collectability, it is important to ensure that information is handled and tracked effectively from citation issuance, which originates in OPW, to the collection of unpaid bills which is managed by the Department of Finance. Funding for the purchase and activation of handheld devices, related software applications, and training for staff will ensure staff have a consistent and effective tool for entering, uploading, and processing citations and fine collection. This relatively small investment has the potential to reduce dumping as collectable fines are a much greater deterrent to illegal behavior.

- **Staffing (including overtime) to expand installation and relocation of illegal dumping cameras; collection of unpaid fines; intake and processing of footage; and issuing citations.** Current staffing to support the enforcement process is limited. The Environmental Enforcement Unit has had several vacancies for over two years, and one of its eight originally budgeted positions remains frozen due to budget shortfalls. Funding to support staff overtime work to both install cameras at new locations and review and process footage caught on those cameras will help the city maximize its minimal staffing resources.

The Illegal Dumping Expenditures Action Plan is shown as Table 1.

In order to act with urgency to remedy illegal dumping, to enhance education, eradication, and enforcement with strengthened technology, equipment, personnel, and outreach, the Plan recommends that Council waive the applicable L/SLBE, RFP/Q, and multi-step solicitation process requirements for the rental of lightning loader trucks due to these vehicles not being available from any Oakland-based company.

Furthermore, this Expenditure Plan does provide substantial funding at the local level and attains the policy goal of ensuring that 50% of expenditures remain in the local economy, to support our local community. In each case where a local option exists, it is utilized. For

example, a substantial portion of the funds will be used for the local city of Oakland workforce, thus supporting our local economy and keeping funds circulating for the well-being of our local community, through the use of "in-sourcing" much of the work. In addition, local contractors and local providers have been identified and are being utilized when possible, including, for example, the local non-profit Keep Oakland Beautiful and local outreach consultants.

For the timely and coordinated acquisition of technology items, existing contracts would be used, including, for example, Verizon for hand-held devices (tablets) and activation. Verizon has multiple facilities within the City of Oakland. For enforcement cameras and solar power, an existing provider would be used, who has already been selected by the city and approved by the Council in a prior process. This would help ensure that the additional equipment would be compatible with the cameras Oakland has already purchased. When a needed item is unique or rare, and no Oakland provider exists, use of another provider will be allowed, in order to enable needed efforts. Specifically, lightning loader trucks (also known as Grapple trucks) are important pieces of equipment that make illegal dumping remediation substantially more efficient and rapid, and reduces risks and harms to the public and the workforce. No provider for such equipment is found in Oakland.

It is also recommended that the City Administrator is expressly authorized to seek and apply for additional funds from public and private sources that fund actions that support the Plan. Finally, it is recommended that the city pursue partnerships and support with county, regional and/or state agencies in furtherance of these efforts.

By taking action to remedy illegal dumping, hold violators accountable, and reduce the amount abandoned trash, this Plan can help improve Oakland both economically and environmentally. The proposed actions are intended to create a healthier and more welcoming environment by protecting people, waterways, air, neighborhoods, and parks from harmful pollutants and runoff, and strengthen our economy by supporting and attracting residents, businesses, and visitors, and enhancing conditions for the city workforce.

WAIVER RATIONALE

A waiver of the city's advertising, competitive bidding, and Local/Small Local Business Enterprise Program is requested for the rental of up to two "Lightning Loader" trucks as there are no local vendors who rent these pieces of equipment. Lightning loader trucks, also known as grapple trucks, are highly specialized pieces of equipment that are stocked and/or sold by a limited number of vendors. The selected vendor, Big Truck Rental, is headquartered in Tampa with a California location in Fresno.

The rental of the equipment will be for a limited duration while the city seeks funding to purchase one or more of these vehicles for its fleet. As mentioned above, a lightning loader truck is an important piece of equipment that makes illegal dumping remediation substantially more efficient and rapid and reduces risks and harms to the public and the workforce.

RELATED PLANNING EFFORTS

The recommended actions in the proposed Plan will help to more equitably and effectively remove abandoned trash from streets, sidewalks, and other public spaces, deter and prevent violations, and help the public better access services for proper waste disposal. As such the Plan will help support and enhance City Council adopted Strategic Planning efforts including:

Equitable Climate Action Plan (ECAP)

This Plan supports several goals of the [ECAP](#) including:

- "Support the Reuse, Repair, Recovery, and Refurbishment Economy" by providing for better materials recovery, deterring dumping which causes deterioration of otherwise reusable items, and promoting effective collection and reuse of items and materials.
- "Evaluate and Reduce Climate Impacts of City Expenditures and Operation" by providing for more accurate, equitable, and geographic zone-based deployment for remediation, as well as use of more efficient equipment, thus reducing driving time, fuel use, and Vehicle Miles Traveled. Additionally, by making the public rights of way cleaner and easier to navigate, this plan removes impediments to walking, biking, and public transit use.

Economic Development Action Plan (EDAP)

By enhancing conditions for business attraction and development, this Plan supports the goals of [Oakland's Economic Development Action Plan](#), including:

- "Facilitating investment in key business corridors and under-resourced neighborhoods, ensuring that the built environment supports economic activity and sustained community well-being" by engaging in targeted, equitable and efficient removal of abandoned trash from hard-hit communities
- "Position Oakland as a competitive, innovation-driven economy," by investing in innovative systems and more effective technologies.

FISCAL IMPACT

The funding for these proposed actions has been budgeted by Council in Fund 1720 as part of the FY 2025-2027 Adopted Biennial Budget. There is no impact on the City's General-Purpose Fund.

PUBLIC OUTREACH / INTEREST

Public outreach and community input regarding the proposed resolution has come from multiple sources, including many strong expressions of community interest in preventing and remedying illegal dumping. The proposed expenditures respond to many requests the city has received for greater investment in addressing illegal dumping, including most recently and notably a meeting of Faith in Action East Bay meeting at Allen Temple Baptist Church with many hundreds of participants. Calls to action have included requesting the city to spend additional resources to pick up more debris quickly and efficiently, to catch and fine dumpers, and to support community needs around proper debris disposal. The resolution suggests a series of actions that respond to these repeated requests from the community.

COORDINATION

Coordination on the actions recommended in this resolution has included Oakland Public Works, the Finance Department, the City Administrator's Office, the Department of Race and Equity, the Office of the City Attorney, and the Mayor's Office. This report and legislation have been reviewed by the Office of the City Attorney and the Budget Bureau.

RACE AND EQUITY

Illegal dumping has been concentrated disproportionately on lower-income neighborhoods, and especially in Black and Latino communities. The dumped piles of waste create blight, attract nuisance and crime, worsen public health, neighborhood ambiance, and public safety, cause environmental harm, and undermine respect for impacted communities. By helping to prevent and remedy illegal dumping, the actions proposed in the resolution will help alleviate some of these inequities.

In the recently adopted Illegal Dumping Enforcement Ordinance staff worked with the Department of Race and Equity to ensure the ordinance is applied equitably across Oakland. This includes asking the City Administrator to establish mechanisms to measure enforcement and penalties in priority areas, and a requirement to report back to City Council with information about fines issued, the cost of enforcement, and cost of collections related to priority areas identified in the Geographic Equity Toolkit [placeholder for link]. These steps will be critical to ensuring equity as the systems to track and ensure collection of illegal dumping citations are improved. The City Administrator was also directed by Council to build out a no-cost, community

service in lieu of payment option for the resolution of fines from an illegal dumping citation. This will ensure that enforcement does not create an undue burden on a violator who cannot afford the fine amount.

The proposed actions include the introduction of a technology to strengthen removal of dumping from hard-hit areas by pilot testing a mechanism, Aerbits, Inc., to deploy crews for cleaning that does not rely on a complaint-based system. Such systems tend to favor more highly resourced communities and worsen inequities. The removal of waste materials should not be reliant on a resident being sufficiently resourced to call in a complaint. If found to be effective, staff will seek resources to expand the Aerbits system citywide with a focus first on those communities disproportionately impacted by dumping.

The expenditure plan also includes improved removal of abandoned trash, through both enhanced staff time for geographically-targeted overtime deployments to remove waste from hard-hit neighborhoods, especially those identified as suffering from inequitable disproportionate impacts, and also includes equipment, such as Lightning Loaders, which strengthen the speed and effectiveness of these efforts.

Another inequity which has been identified is regarding access to and usage of free bulky waste removal services. The city offers free bulky item curbside pickup and drop-off appointments through its mixed materials and organics franchise agreement with Waste Management. Data from the program, however, shows that it is significantly underutilized, with the least usage by residents of multi-family properties. In addition, data shows it is disproportionately under-used by Spanish-speaking communities, and by those in East and West Oakland. Thus, highly impacted communities, disproportionately communities of color and lower-income communities, are under-served by the free bulky waste removal program. This expenditure plan works to help remedy this inequity by expanding community outreach, education, and direct support for the use of this free debris disposal service, especially for under-served communities, and in multiple languages, with a focus on the areas which have been underserved, and on those in apartments for whom the service has been under-utilized.

ACTION REQUESTED OF THE CITY COUNCIL

Staff recommends that the city council adopt a resolution acknowledging the urgency and expediting actions to remedy illegal dumping through an illegal dumping expenditures action (idea) plan:

- 1) Authorizing the City Administrator to a) implement the IDEA plan by negotiating and entering into contracts, grant agreements, and expenditures as set forth in Table 1 in a total amount not to exceed \$1,100,000; and b) pursue partnerships with county, regional and/or state agencies to enhance these efforts;
- 2) Waiving, to the extent necessary, the city's advertising, competitive bidding, and local /small local business enterprise program participation and multi-step technology acquisition requirements for the contracts; and waiving the local / small local business enterprise program requirement for the Big Truck Rental (lightning loader) contract;

- 3) Appropriating and allocating an amount not to exceed \$1,100,000 from budgeted funds in fund 1720, Comprehensive Cleanup Fund, for these purposes;
- 4) Accepting and appropriating additional funds from public and private sources and authorizing the City Administrator to actively seek and apply for such funds and to amend existing contracts and/or enter into new contracts consistent with the purpose of this resolution and in furtherance of the plan in a total amount not to exceed the value of such additionally appropriated funds; and
- 5) Directing the City Administrator to return to Council within one year of the adoption of this resolution to provide an informational report on actions taken, funds received and expended, and contracts awarded pursuant to this Plan and the authority granted by this resolution.

**RESOLUTION ACKNOWLEDGING THE URGENCY AND EXPEDITING
ACTIONS TO REMEDY ILLEGAL DUMPING THROUGH AN ILLEGAL
DUMPING EXPENDITURES ACTION (IDEA) PLAN:**

- 1) **AUTHORIZING THE CITY ADMINISTRATOR TO A) IMPLEMENT THE IDEA PLAN BY NEGOTIATING AND ENTERING INTO CONTRACTS, GRANT AGREEMENTS, AND EXPENDITURES AS SET FORTH IN TABLE 1 IN A TOTAL AMOUNT NOT TO EXCEED \$1,100,000; AND B) PURSUE PARTNERSHIPS WITH COUNTY, REGIONAL AND/OR STATE AGENCIES TO ENHANCE THESE EFFORTS;**
- 2) **WAIVING, TO THE EXTENT NECESSARY, THE CITY'S ADVERTISING, COMPETITIVE BIDDING AND MULTI-STEP TECHNOLOGY ACQUISITION REQUIREMENTS FOR THE CONTRACTS; AND WAIVING THE LOCAL /SMALL LOCAL BUSINESS ENTERPRISE PROGRAM REQUIREMENT FOR THE BIG TRUCK RENTAL (LIGHTNING LOADER) CONTRACT;**
- 3) **APPROPRIATING AND ALLOCATING AN AMOUNT NOT TO EXCEED \$1,100,000 FROM BUDGETED FUNDS IN FUND 1720, COMPREHENSIVE CLEANUP FUND, FOR THESE PURPOSES;**
- 4) **ACCEPTING AND APPROPRIATING ADDITIONAL FUNDS FROM PUBLIC AND PRIVATE SOURCES AND AUTHORIZING THE CITY ADMINISTRATOR TO ACTIVELY SEEK AND APPLY FOR SUCH FUNDS AND TO AMEND EXISTING CONTRACTS AND/OR ENTER INTO NEW CONTRACTS CONSISTENT WITH THE PURPOSE OF THIS RESOLUTION AND IN FURTHERANCE OF THE PLAN IN A TOTAL AMOUNT NOT TO EXCEED THE VALUE OF SUCH ADDITIONALLY APPROPRIATED FUNDS; AND**
- 5) **DIRECTING THE CITY ADMINISTRATOR TO RETURN TO COUNCIL WITHIN ONE YEAR OF THE ADOPTION OF THIS RESOLUTION TO PROVIDE AN INFORMATIONAL REPORT ON ACTIONS TAKEN, FUNDS RECEIVED AND EXPENDED, AND**

**CONTRACTS AWARDED PURSUANT TO THIS PLAN AND THE
AUTHORITY GRANTED BY THIS RESOLUTION**

WHEREAS, illegal dumping damages community, economy, the environment, and public health; and

WHEREAS, Oakland is determined to act with urgency to remedy illegal dumping; and

WHEREAS, timely and effective cleanup and removal of illegal dumping is vital to ensuring a clean, safe, healthy and vibrant community, and these goals are strengthened through the acquisition and use of effective, viable, equipment, personnel resources, including overtime, and technology that can track, identify, and shorten cleanup timelines; and

WHEREAS, educating the public about the harmful impacts of illegal dumping, the importance of preventing it, and available, lawful methods of waste disposals can help reduce incidences of illegal dumping; and

WHEREAS, numerous residents, community groups, and stakeholders have urged increased action to remove abandoned trash and solve the inequities of some communities being disproportionately dumped on, including by using more pro-active and zone-based removal systems; and

WHEREAS, identifying and addressing root causes that drive negative outcomes is on the critical path to problem solving that produces meaningful improvement and outcomes; and

WHEREAS, the meaningful measure of successful problem solving is evaluation of actions for, how much did we do, how well did we do it and who is better off because of changes that have been implemented; and

WHEREAS, equity focus benefits all residents of Oakland by removing barriers to access and improving conditions for all who encounter those conditions; and

WHEREAS, the City Administrator is authorized to initiate an illegal dumping problem-solving process that is driven by root cause analysis of the chronic presence of trash in priority areas of the City as defined by the Geographic Equity Toolkit <https://www.oaklandca.gov/Community/Community-Development/Neighborhood-Improvement/Geographic-Equity-Toolbox>, to develop parallel comprehensive strategies that address complex challenges; and

WHEREAS, the City Administrator is authorized to establish mechanisms to measure the impact of increased enforcement and penalties on the amount of trash present in priority areas; and

WHEREAS, the City Administrator is authorized to establish mechanisms to track amount of fines levied, amount of fines collected, the cost of enforcement, and the cost of collections related to priority areas, to be reported annually to the City Council; and

WHEREAS, in order to catch illegal dumpers, and deter dumping, it is useful to expand capacity for catching them on camera, including through the use of solar-powered cameras which can more readily be deployed and re-deployed to target evolving hot spots; and

WHEREAS, recommended best practices from multiple sources, including the annual Illegal Dumping Convention hosted by Alameda County Supervisor Nate Miley, have encouraged strengthening the issuance of administrative citations to those involved in illegal dumping; and

WHEREAS, working collaboratively together with funders and foundations, the county, and regional and state agencies can enhance the effectiveness of work to crack down on illegal dumpers, including dealing with violators who cross city lines; and

WHEREAS, the City Council, in adopting the June 2025 budget, expressed the importance of taking urgent and expedited action to remedy illegal dumping, and set aside funding to support the implementation of innovative solutions to illegal dumping; and

WHEREAS, said funding is listed for use in the current fiscal year, and the City wishes to act to ensure that the Illegal Dumping Expenditure Action Plan, which seeks to remedy illegal dumping through eradication, enforcement and education can be conducted expeditiously; and

WHEREAS, in order to act in a rapid and timely manner, and utilize the designated funds within the intended timeline, it is necessary to expedite the steps needed to acquire the relevant technology and equipment; and

WHEREAS, the City seeks to maximize effectiveness of the projects in this Resolution, and to surge operations to help clear backlogs and hard-hit areas, including, when available, to enable additional personnel to assist in these efforts; and

WHEREAS, the City Administrator recommends approval of the Illegal Dumping Expenditures Action Plan (Table 1) and recommends approval of the following contracts, grants, and other expenditures in an amount not to exceed \$1,100,000 as follows:

WHEREAS, the City Administrator seeks approval of the above contracts to the extent they exceed or—with additionally authorized and appropriated funds as approved by the Resolution—will exceed, the City Administrator’s purchase authority as set forth in 2.04.020; and

WHEREAS, the City Administrator has determined that the aforementioned service agreements are of a professional and temporary nature and shall not result in the loss of employment or salary by any person having permanent status in the competitive civil service; and

WHEREAS, on April 14, 2026, Council passed Resolution 91112 C.M.S. authorizing the City Administrator to enter into a contract with Aerbits, Inc. for \$150,000 to use aerial camera technology to identify the location, volume, and type of abandoned trash (illegal dumping) on public rights of way and public property in the City of Oakland; and

WHEREAS, OMC Section 2.04.042.B requires that the City Administrator conduct a competitive multiple-step solicitation process for the acquisition of any computerized or information technology systems; and

WHEREAS, OMC Section 2.04.042.D provides that the City Council may waive the competitive multiple-step solicitation process upon a recommendation of the City Administrator and finding and determination by the City Council that it is in the best interests of the City to waive the solicitation processes; and

WHEREAS, OMC Section 2.04.051(B) authorizes the City Council to waive the competitive Request for Proposal/Request for Qualifications ("RFP/RFQ") requirements for contracts in any amount upon finding that it is in the best interests of the City to do so; and

WHEREAS, the Council may waive the City's L/SLBE requirements for professional services contracts pursuant to Part I of Oakland's Local and Small Local Business Enterprise (L/SLBE) Program guidelines adopted by Ordinance No. 13825 C.M.S.; and

WHEREAS, the City Administrator recommends that Council waive the applicable RFP/Q and multi-step solicitation process requirements for the actions set forth above because waiving these processes will allow the City to move expediently, and to utilize available special technologies, resulting in more immediate and effective action to implement the Plan;

WHEREAS, the City Administrator recommends that Council waive the L/SLBE program requirements for the Big Truck Rental contract to rent lightning loader trucks to support more timely, efficient and safe removal of abandoned trash and such equipment is specialized and not readily available locally; and

WHEREAS, Council expressly approves and, to the extent necessary, appropriates an amount not to exceed one million one hundred thousand dollars (\$1,100,000) from the budgeted and available funds in Fund 1720, Comprehensive Cleanup Fund, that Council previously designated for these purposes; and

WHEREAS, the City Administrator will actively seek and apply for funds from public and private sources to further support the Plan; and the Council hereby proactively appropriates such funds to support these actions should such funds become available into Fund 1720; and

WHEREAS, the Council authorizes the City Administrator to amend existing contracts and/or enter into new contracts consistent with the purpose of this Resolution in furtherance of the Plan in a total amount not to exceed the value of such additionally appropriated funds and finds that it is in the best interests of the City to waive the RFP/Q and multi-step competitive solicitation process requirements for such contracts, if applicable; and; now, therefore, be it

RESOLVED: That the City Council hereby adopts the Illegal Dumping Expenditures Action (IDEA) Plan (Table 1) and the City Administrator is authorized to take action to implement the Plan, as described herein; and be it

RESOLVED: That City Administrator is authorized to negotiate and enter into contracts, grant agreements, and expenditures as set forth in Table 1 in a total amount not to exceed one million one hundred thousand dollars (\$1,100,000) except as set forth herein, and to pursue partnerships with county, regional and/or state agencies to enhance these efforts; and be it

FURTHER RESOLVED: That to the extent that such purchases exceed the City Administrators purchase authority set forth in OMC 2.04.020, the City Administrator is expressly authorized to negotiate and enter into the contracts and make the expenditures set forth herein and in the Plan for the purposes set forth herein and in the Plan and has authority to determine whether to enter into new contracts or amend and increase the value of existing contracts consistent with this Resolution and/or in furtherance of the Plan; and be it

FURTHER RESOLVED: That for the reasons stated herein and in the report that accompanies this Resolution, the City Council hereby finds and determines that it is in the best interests of the City to waive the (1) RFP/Q requirements pursuant to OMC section 2.04.051(B), and (2) competitive multiple-step solicitation process pursuant to OMC section 2.04.042.D for the contracts, products, and services to be purchased and implemented as set forth in Table 1, as applicable and so waives the requirements; and be it

FURTHER RESOLVED: That for the reasons stated herein and in the report that accompanies this Resolution, the City Council hereby finds and determines that it is in the best interests of the City to waive L/SLBE program participation requirements pursuant to Oakland's Local and Small Local Business Enterprise Program guidelines adopted by Ordinance No. 13825 C.M.S., for the Big Truck Rental contract to rent lightning loader trucks and so waives the requirements; and be it

FURTHER RESOLVED: That to the extent that such amended or additional contracts would otherwise require compliance with the RFP/Q or multiple-step solicitation program requirements as set forth by OMC section 2.04.051(B) and OMC section 2.04.042.D, respectively, the Council finds that it is in the best interests of the City to waive these requirements; and be it

FURTHER RESOLVED: That the City Administrator is authorized to negotiate and enter into a grant agreement for up to forty-thousand dollars (\$40,000) with Keep Oakland Beautiful, to support public outreach, community beautification, and education about preventing illegal dumping and the use of proper and lawful debris disposal methods; and be it

FURTHER RESOLVED: That the City Council authorizes and appropriates funding for these items in a total amount not to exceed one million one hundred thousand dollars (\$1,100,000) from monies available in Fund 1720, Comprehensive Cleanup Fund; and be it

FURTHER RESOLVED: That the City Council hereby accepts and appropriates additional funds from public and private sources and authorizes the City Administrator to seek and apply for such funds to support the Plan, and to pursue partnerships and support with county, regional and/or state agencies in furtherance of these efforts and to amend existing contracts and/or enter into new contracts consistent with the purpose of this Resolution and in furtherance of the

Plan in any amount, so long as the total amount does not to exceed the value of such additionally appropriated funds; and be it

FURTHER RESOLVED: That the City Administrator is authorized to mobilize additional personnel to support this Plan, including by the use of overtime and, consistent with the law and applicable MOUs, authorizing those who can provide work beyond their usual roles, including, where appropriate, serving in an Annuitant or Acting capacity, to support a surge to clean up Oakland; and be it

FURTHER RESOLVED: That the City Administrator shall be authorized to reallocate funds between items in the Plan as set forth in Table 1, as appropriate, based on operational needs, and in their discretion, including if other funding sources become available for backfill; and be it

FURTHER RESOLVED: That the City Administrator is authorized to take such actions as necessary and appropriate to effectuate this Resolution in a timely manner and shall return to the City Council with an informational report detailing actions taken, funding received and expended, and contracts awarded pursuant to this Resolution or in furtherance of the Plan, within one year of adoption of this Resolution.
